Dr. Kevin Purgiel, General Surgeon, was ready to move his new practice away from paper charts. “I don’t find the paper charts to be long term,” related Dr. Purgiel. “That era is done and gone. The technology uses an intelligent navigation system and template-free approach to be completely customized to the nuances of each physician, providing a closer fit than customizing just to the specialty of the doctor. “I think what’s good about it is that I’ve been able to change things that needed to be changed,” shared Dr. Purgiel. “I found that most systems are set up for a family physician. With Allscripts, I’ve been able to go through and get rid of the noise and clutter that I don’t really need when I evaluate patients from the perspective of a surgical practice. That’s what’s been nice – that I have been really able to modify my system so that it’s exactly what I want it to be.” Dr. Purgiel also uses features such as allergy alerts to ensure that he always has all relevant information to provide the best care possible to his patients.

The hosted, web-based functionality of Allscripts MyWay enables Dr. Purgiel to access the system from anywhere that Internet access is available. "I don't go anywhere without my notebook," he declared. "I take it everywhere. I just hood up wherever I'm at, get some things done and generate some letter, and do what I need to do."

The doctor states that through the daily workflow efficiencies afforded by MyWay, he no longer routinely takes home charts. He feels that this benefit alone saves him approximately 10 hours per week of his personal time.

A BETTER WAY TO RUN A PRACTICE

Time is not the only area where Dr. Purgiel is saving through Allscripts MyWay. The robust automated documentation capability of the technology has enabled the physician to eliminate \$500-\$600 a month (\$6,000-\$7,200 yearly) in transcription fees.

FUTURE PLANS
